Sub: Revocation of Debarment direction against Sandeep Kumar (PAN- AIZPK7566J) – In the Matter of Megasys Medilife Limited

This has reference to NSE circular No. NSE/INVG/28723 dated January 29, 2015 referring to SEBI order no. WTM/SR/ERO/10/01/2015 and NSE circular No. NSE/INVG/30972 dated October 19, 2015 referring to SEBI order no. WTM/PS/73/ERO/OCT/2015 restraining Megasys Medi Life Limited and its directors Shri Manish Roy, Shri Anil Pandey, Shri Barun Biswas, Shri Sandeep Kumar, Shri Kabir Roy, Smt. Susmita Roychoudhury, Shri Prabir Sengupta and Shri Tufan Kumar Pramanik from accessing the securities market and further prohibiting them from buying, selling or otherwise dealing in the securities market, directly or indirectly in whatsoever manner, from the date of this Order, till the expiry of 4 years from the date of completion of refunds to investors.

Based on the intimation received from SEBI, Shri Sandeep Kumar (PAN- AIZPK7566J) mentioned above, has complied with the directions issued by SAT in its Order dated January 19, 2017. In view the same, debarment direction against the entity, Sandeep Kumar has been revoked.
