Sub: Order in the matter of Jivan Sathi Dream Projects Limited “JSDPL”

This is with reference to NSE circular no. NSE/INVG/31757 dated February 17, 2016 referring to SEBI order no. WTM/SR/SEBI-ERO/IMD/12/2/2016 dated February 17, 2016 restraining M/s Jivan Sathi Dream Projects Limited “JSDPL” (PAN: AACCCJ3999G), Shri Mithun Chakraborty (PAN: AIDPC5794L), Shri Abhijit Khan (PAN: ALPPK7212C), Shri Nilanjan Dutta Chowdhury (PAN: ASDPC5559M), Shri Pradip Chakraborty (PAN: AJJPC6225B), Shri Biswajit Pramanik (PAN: BVJPP4375A), Shri Nitish Chandra Tarafdar (PAN: ABPPT8081J), Smt Shikha Chakraborty (PAN: AKJPC3739K), Shri Chiranjit Kundu (PAN: AVOPK9564G), M/s. Jivan Sathi Life Care Agencies Private Limited (PAN: AACCCJ2454N) and Smt Roshni Guha (PAN: AVJPG3285H) from accessing the securities market and further prohibited from buying, selling or otherwise dealing in the securities, directly or indirectly, or being associated with the securities market in any manner, till further directions.

SEBI, now vide its order no. WTM/MPB/EFD-1-DRA-IV/11/2017 dated August 23, 2017 has passed the following directions:

- JSDPL, Shri Mithun Chakraborty, Shri Abhijit Khan, Shri Nilanjan Dutta Chowdhury, Shri Pradip Chakraborty and Smt Roshni Guha are directed not to, directly or indirectly, access the securities market, by issuing prospectus, offer document or advertisement soliciting money from the public and are further restrained and prohibited from buying, selling or otherwise dealing in the securities market, directly or indirectly in whatsoever manner, from the date of this Order, till the expiry of 4 (four) years from the date of completion of refunds to investors as directed in the Order. The said entities are also restrained from associating themselves with any listed public company and any public company which intends to raise money from the public, or any intermediary registered

with SEBI from the date of this Order till the expiry of 4 (four) years from the date of completion of refunds to investors.

- Shri Biswajit Pramanik, Shri Nitish Chandra Tarafdar, Smt Shikha Chakraborty, Shri Chiranjit Kundu and M/s. Jivan Sathi Life Care Agencies Private Limited are directed not to, directly or indirectly, access the securities market, by issuing prospectus, offer document or advertisement soliciting money from the public and are further restrained and prohibited from buying, selling or otherwise dealing in the securities market, directly or indirectly in whatsoever manner for a period of 4 (four) years from the date of this Order. The said entities are also restrained from associating themselves with any listed public company and any public company which intends to raise money from the public, or any intermediary registered with SEBI for a period of four years from the date of this Order.
