Sub: SEBI Order in the matter of Blue Chip Corporation Pvt. Ltd., Mr. Nitin Rajaram Narke, Mr. Pravin B. Darawade, Ms. Bhavana Chadha, M/s Milestone Investment, M/s Nitin Narke Investment, M/s Blue Cheap Investment and M/s Blue Chip Investment

This is with reference to NSE circular no NSE/INVG/31111 referring to SEBI order no. WTM/RKA/MIRSD/145/2015 dated November 09, 2015 restrained below mentioned entities from accessing the securities market and further prohibited from buying, selling or otherwise dealing in securities, either directly or indirectly, or being associated with the securities market in any manner whatsoever, with immediate effect, till further directions.

SEBI, now vide its order No. WTM/SR / SEBI/EFD-DRA2/56/09/2017 dated September 04, 2017 has directed following entities not to access the securities market directly or indirectly, and are further restrained and prohibited from buying, selling or otherwise dealing in the securities market, directly or indirectly for a period of **ten (10) years** from the date of this Order.
