Sub: SEBI Order in the matter of Moryo Industries Limited

This is with reference to NSE circular no. NSE/INVG/28279 dated December 04, 2014 referring to SEBI order no. WTM/RKA/ 140 /ISD/2014 interalia restraining 85 entities (as mentioned in Annexure I) from accessing the securities market and buying, selling or dealing in securities market, either directly or indirectly, in any manner, till further directions.

Further reference to NSE circular no. NSE circular no. NSE/INVG/32018 dated March 18, 2016 referring to SEBI confirmatory order no. WTM/RKA/ISD/33/2016 and NSE circular no. NSE/INVG/33035 dated August 23, 2016 referring to SEBI order no. WTM/RKA/ISD/100/2016.

SEBI now vide its order no. SEBI/WTM/MPB/EFD-1-DRA-IV/32 /2017 dated September 21, 2017 has stated that the directions issued in the abovementioned orders need not be continued and revoked the the Confirmatory Orders dated March 18, 2016 and August 22, 2016 qua aforesaid 85 entities (as mentioned in Annexure I).

The above directions shall come into force with immediate effect.
