Sub: Addendum to the Order dated October 9, 2017 bearing Reference Number WTM/MPB/EFD-1-DRA-IV/57 /2017 in the matter of Rahul Inn Hospitality Limited (RIHL).

This is with reference to NSE circular no. NSE/INVG/36071 dated October 10, 2017 referring to SEBI order no. WTM/MPB/EFD-1-DRA-IV/57 /2017 dated October 9, 2017 has inter-alia directed Rahul Inn Hospitality Limited (RIHL) and its directors viz., Shri Rahul Banerjee (PAN AIKPB8188N), Shri Abhijit Majumdar, Shri Dipankar Gupta and Shri Mrinmoy Bose not to, directly or indirectly, access the securities market, by issuing prospectus, offer document or advertisement soliciting money from the public and are further restrained and prohibited from buying, selling or otherwise dealing in the securities market, directly or indirectly in whatsoever manner, from the date of this Order, till the expiry of 4 (four) years from the date of completion of refunds to investors as directed in the Order.

Restrained Shri Chapal Biswas and Shri Chinmoy Ghatak from accessing the securities market and are further restrained from buying, selling or dealing in securities, in any manner whatsoever, for a period of 4 (four) years from the date of this Order.

SEBI now, vide its Order No.WTM/MPB/EFD-1-DRA-IV/57A/2017 dated November 15, 2017 has stated that the effect and implementation of the said SEBI Order is subject to the directions passed by the Hon'ble Calcutta High Court in its Order dated August 12, 2016 in W.P. No.17904 (W) of 2015 in respect of Rahul Group of Companies.

Members are advised to take note of the above and ensure compliance.
