Sub: SEBI Order in the matter of Real Sunshine Corp Limited (Earlier known as Real Sunshine Agrotech Limited)

This is with reference to NSE circular no. NSE/INVG/29121 dated March 13, 2015 referring to SEBI order no. WTM/SR/WRO/44 /03 /2015 dated March 13, 2015 restraining Real Sunshine Corp Limited, Shri Abdul Wahid, Shri Pradeep Ojha, Shri Anil Kumar, Shri Bipin Singh Yadav, Shri Rajkumar Yadav, Shri Atendra Kumar, Shri Siba Prosad Ghosh and Shri Jitendra Singh Yadav from accessing the securities market and further prohibiting buying, selling or otherwise dealing in securities in any manner whatsoever, either directly or indirectly, till further directions.

SEBI, now vide its order no. WTM/MPB/EFD-1-DRA-IV/ 139 /2018 dated February 15, 2018 has directed the following entities not to, directly or indirectly, access the securities market, by issuing prospectus, offer document or advertisement soliciting money from the public and are further restrained and prohibited from buying, selling or otherwise dealing in the securities market, directly or indirectly in whatsoever manner, from the date of this Order, till the expiry of 4 (four) years from the date of completion of refunds to investors.
