WTM/GM/EFD/100/2017-18 dated March 19, 2018 has restrained / prohibited following entities from accessing the securities market and are further prohibiting them from buying, selling or otherwise dealing in securities in any manner whatsoever, either directly or indirectly till the directions for refund/repayment to the investors are complied with, as directed at pre paras to the satisfaction of SEBI and WRR/ Report of completion of payment with SEBI is submitted to SEBI and for a further period of four years from the date of completion of the refund :-
