Sub: Hon'ble Supreme Court of India order in the matter of Satyam Computer Services Ltd.

This is with reference to NSE circular no. NSE/INVG/30730 dated September 10, 2015 referring to SEBI Order no. WTM/RKA/EFD-SRO/108-117/2015 dated September 10, 2015 inter-alia restraining following entities from accessing the securities market and further prohibit them from buying, selling or otherwise dealing in securities, directly or indirectly, or being associated with the securities market in any manner, whatsoever, for a period of 07 years:-
