Sub: SEBI Order in the matter of Vital Communications Limited.

This is with reference to SEBI order no. WTM/RKA/IVD/ID-08/72-95/2014 dated July 31 2014 read with Corrigendum no. WTM/RKA/EFD-DRA1/164/2014 dated December 26, 2014.

SEBI, now vide its order no. WTM/GM/EFD/DRA-I/59/2018-19 dated September 28, 2018 has issued directions that if following entities fail to comply with the directions of the said SEBI Order within a period of 45 days from the date of this order, they shall be restrained from buying, selling or dealing in securities market in any manner whatsoever or accessing the securities market, directly or indirectly, for a period of five years from the end of the specified time of 45 days. The same shall be without prejudice to SEBI's right to initiate appropriate enforcement action under SEBI Act, 1992 including Recovery, Adjudication or Prosecution:
