1. The controversy involved in the present appeal is squarely covered by the judgment of this Tribunal dated March 12, 2019 passed in Appeal No. 80 of 2019, North End Foods Marketing Pvt. Ltd. & Anr. vs. Securities and Exchange Board of India and other companion appeals.
