Sub: SEBI order in the matter of Pine Animation Limited.

This is with reference to NSE circular no NSE/INVG/29664 dated May 09, 2015 in the matter of Pine Animation Limited wherein SEBI vide its ad-interim ex-parte order no. WTM/RKA/ISD/36/2015 dated May 08, 2015 has restrained various entities from accessing the securities market and buying, selling or dealing in the securities market, either directly or indirectly, in any manner, till further directions.

SEBI now, vide its order no. WTM/SM/IVD/ID6/5558/2019-20 dated November 18, 2019 has debarred various entities as attached in the Annexure from accessing the securities market and further prohibit them from buying, selling or otherwise dealing in securities, directly or indirectly, or being associated with the securities market in any manner, whatsoever, for the respective periods as specified in the Annexure, from the date of this order.

It is further clarified that during the period of restrained the existing holding of securities, including the units of mutual funds shall remain under freeze.

It is clarified that while calculating the period of debarment as directed in the Order, the period already undergone by the respective entities, in pursuance of the above Interim Order shall be taken into consideration and the same shall be set-off to give effect to the directions of restraint and prohibition as directed in the Order.

With respect to below mentioned entities, for the reasons recorded in the order while dealing with the allegations against these entities, the allegations and charges made against them have not been found sustainable, hence, the proceedings against them are hereby being disposed of without any directions:
