SEBI vide its Order No. WTM/MPB/IMD/SRO-BLO/157/2020 dated December 15, 2020 has hereby VRP Capital & Derivative Market Services and its proprietor Mr. Vaibhav Ramchandra Patil (BAYPP4608L) not to access the securities market and buy, sell or otherwise deal in securities in any manner whatsoever, directly or indirectly, until further orders.

Further, VRP Capital or its sole proprietor has any open positions in any exchange traded derivative contracts, as on the date of the order, they can close out/ square off such open positions within 3 months from the date of order or at the expiry of such contracts, whichever is earlier.

Also, VRP Capital or its sole proprietor is permitted to settle the pay-in and pay-out obligations in respect of transactions, if any, which have taken place before the close of trading on the date of this order.

This order shall come into force with immediate effect and shall be in force until further orders.
