Sub: SEBI Order in the matter of Vinayak Tradelink (Prop. Mr. Vivek Mahendragiri Ramdati)

SEBI vide its Order No. WTM/MPB/IMD/WRO/158/2020 dated December 16, 2020 has hereby directed Vinayak Tradelink and its Proprietor, Mr. Vivek Mahendragiri Ramdati (PAN: BBSPK1145A) not to access the securities market and buy, sell or otherwise deal in securities in any manner whatsoever, directly or indirectly, until further orders.

Further, if Vinayak Tradelink or its Proprietor, Mr. Vivek Mahendragiri Ramdati, have any open position in any exchange traded derivative contracts, as on the date of the order, they can close out/ square off such open positions within 3 months from the date of order or at the expiry of such contracts, whichever is earlier.

Also, Vinayak Tradelink and its Proprietor, Mr. Vivek Mahendragiri Ramdati, are permitted to settle the pay-in and pay-out obligations in respect of transactions, if any, which have taken place before the close of trading on the date of the order.

This order shall come into force with immediate effect.
