SAT vide its order dated January 15, 2021 has stayed the effect and operation of the impugned order provided the appellant - Ms. Prenita Dutt & Ors (PAN - ABPPD3026K) deposits a sum of Rs. 1 crore on or before the next date and file proof of such Deposit.
