Sub: Final Order in the matter of Max India Research (Proprietor: Abhishek Gupta)

SEBI vide its final order no. WTM/AB/WRO/ILO/14/2021-22 dated June 11, 2021 has hereby debarred entity M/s. Max India Research (Proprietor: Mr. Abhishek Gupta) (PAN: BKEPG0910Q) from accessing the securities market, directly or indirectly and are prohibited from buying, selling or otherwise dealing in the securities market, directly or indirectly in any manner whatsoever, for a period of 2 (two) years from the date of the order or till the expiry of 2 (two) years from the date of completion of refunds to investors as directed in paragraph 17(i) of the SEBI Order, whichever is later.

The Order shall come into force with immediate effect.
