Sub: SEBI Order in the matter of RTS Power Corporation Limited.

This is with reference to NSE circular no. NSE/INVG/2009/298 dated June 08, 2009 referring to SEBI order No. WTM/KMA/81/ISD/06/2009 dated June 05, 2009 had restrained certain entities from accessing the securities market and further prohibited them from buying, selling or dealing in securities market, directly or indirectly, till further orders.

Now, SEBI vide its order No. WTM/GM/EFD/DRA1/13919/2021-22 dated October 27, 2021 has restrained following entities from accessing the securities market and prohibited from buying, selling or otherwise dealing in securities, directly or indirectly, or being associated with the securities market in any manner for the period mentioned below from the date of SEBI order:

Further, SEBI has clarified in para 75 of the SEBI order that in compliance with the order of the Hon'ble Bombay High Court dated October 27, 2020, in Writ Petition (L) No. 280 of 2015, the direction contained in SEBI order qua entities Hetal Patel (AQUPP6130E) and Rajesh Patel (AQUPP6874F) shall not be enforced until the final disposal of the said writ petition and also shall be subject to the decision therein.

Subject to the direction in para 75 of the SEBI order, this SEBI Order shall come into force with immediate effect.
