Sub: Corrigendum to the Final SEBI Order in the matter of Right Target Advisory Services

This is with reference to NSE Circular No. NSE/INVG/51790 dated March 28, 2022 in respect of SEBI Order No. WTM/SM/SRO/SRO/15641/2021-22 dated March 28, 2022, wherein SEBI had debarred the below entities from accessing the securities market, directly or indirectly and prohibited the entities from buying, selling or otherwise dealing in the securities market, directly or indirectly in any manner whatsoever, for a period of 06 (six) months from the date of the SEBI Order no. WTM/SM/SRO/SRO/15641/2021-22 or till the expiry of 06 (six) months from the date of completion of refunds to investors as directed in paragraph 49.1 of the SEBI Order, whichever is later.
