This is with reference to NSE Circular no. NSE/INVG/56908 dated May 31, 2023 in respect of SEBI Order No. WTM/AB/NRO/NRO/26999/2023-24 dated May 31, 2023.

SEBI now vide a corrigendum Order No. WTM/AB/NRO/NRO/27027/2023-24 dated Jun 01, 2023 has informed that in the final Order, at serial no. 2 in the table given at page no. 1, the PAN of Shri Kamaldeep Singh (Noticee no. 2 in the Final Order), has been inadvertently mentioned as “BHKSPS0236E”, instead of “BKHPS0236E”.
