Sub: SAT Order In the matter of Front Running: Various Funds of Fidelity Group

This is with reference to NSE circular no. NSE/INVG/52531 dated June 03, 2023 in reference to SEBI Order no. WTM/AB/IVD/ID3/16889/2022-23 dated June 03, 2023 wherein SEBI has restrained Pramod Jain HUF (AALHP5134K) from accessing the securities market and further prohibited him from buying, selling or otherwise dealing in securities, directly or indirectly as may be applicable for period mentioned in SEBI order.

Now Hon'ble SAT vide its order dated October 30, 2023 with reference to Misc. Application No. 1262 of 2023 made by Pramod Jain HUF (AALHP5134K) has directed that the effect and operation of the impugned order in so far as it relates to the appellant. The application is disposed of.
