This has reference to NSE circular no. NSE/INVG/51124 dated January 10, 2020 in respect of SEBI Order No. WTM/MPB/IMD/ILO/100/2020 dated February 07, 2020 wherein SEBI has restrained below mentioned entity from accessing the securities market and are further prohibited from buying, selling, or otherwise dealing in securities, either directly or indirectly, whatsoever, for the period mentioned in SEBI order.

SEBI vide Corrigendum no.
