To All NSE Members,

Sub: Corrigendum to the SEBI Order dated May 29, 2025 in the matter of Sadhna Broadcast Limited

This is with reference to NSE Circular No. NSE/INVG/68258 and SEBI Order No. WTM/AB/ISD/ISD-SEC-5/31442/2025-26 dated May 29, 2025, wherein SEBI has issued the following directions:

- Noticees- 1, 2, 21, 25, 26, 39 and 52 are restrained from accessing the securities market and further prohibited from buying, selling or otherwise dealing in securities, directly or indirectly, or being associated with the securities market in any manner, whatsoever, for a period of five (5) years from the date of this Order.
- Noticees- 3, 4-7, 9-13, 15-20, 22-24, 27-38, 40-47, 49-51, 53-58 and 60-63 are restrained from accessing the securities market and further prohibited from buying, selling or otherwise dealing in securities, directly or indirectly, or being associated with the securities market in any manner, whatsoever, for a period of one (1) year from the date of this Order.

Further, SEBI vide para no 278 (j) has directed that Proceedings against Noticees. 13, 48 and 64 are being disposed of without issuance of any directions.

SEBI now vide Order No. WTM/AB/ISD/ISD-SEC-5/31446/2025-26 dated May 30, 2025 has issued a corrigendum stating that in Para no. 278 (j) of the above Order, the word and figures "Noticees 13" shall be read as "Noticees 14".
