Purpose

This document describes the protocol for Web API based real time communication between NSE and its Trading Members. The document serves as a common guide for developing and testing interfaces between systems at Exchange and its Members.

Scope

Bidirectional external interface API's will be provided as REST endpoints accessible over internet using HTTPS protocol. All messages in the online API's will be in JSON format.

Target Audience

All trading members wants to send their client information to NSE would consume the exchange end-point.

Messaging Protocols

- Messages or all request and response messages are in JSON (JavaScript Object Notation) format.
- Following headers need to be provided in all API calls
 - a. Content-Type: Header value should be “application/json”
- A value could be Boolean (true/false), number, decimal, String or a structure (List or Object).
- All dates, times and date times are represented in Indian standard time.
- For date fields, format will be varied from API to API and the details will be provided on respective API.

Authorization

- The API consumer application is expected to send following headers (case-sensitive) in every API HTTPS request.
 - Token: A unique identifier generated for all successful login.
- The API provider is not required to provide any header in its response.
- Token will have expiry of 30 minutes.

JWT mechanism is used to generate API authentication tokens as it is widely used industry standard.

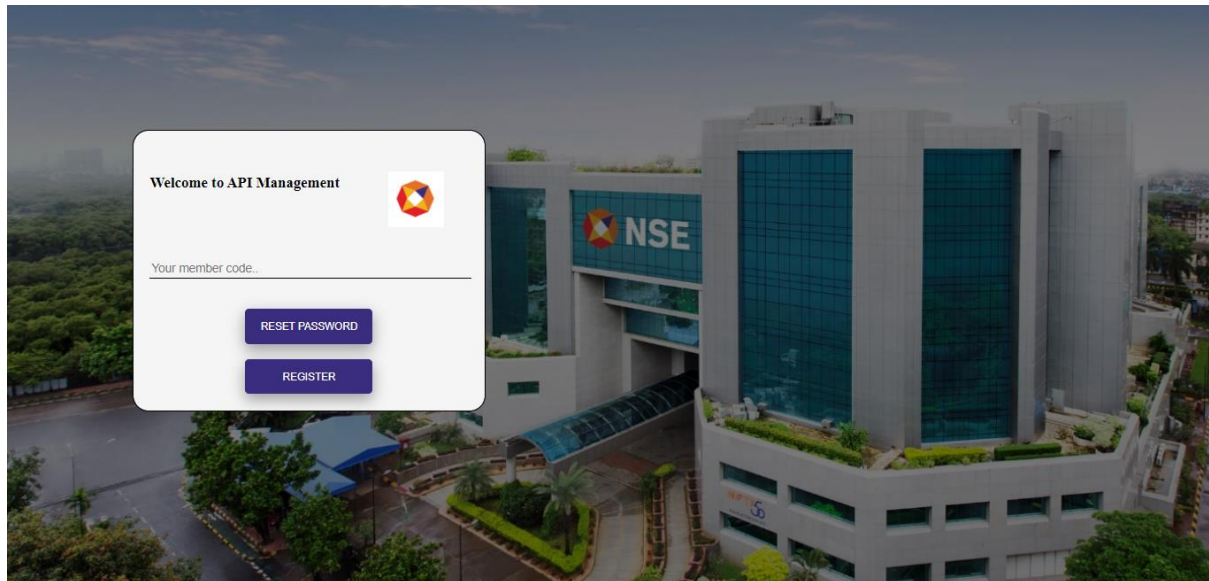

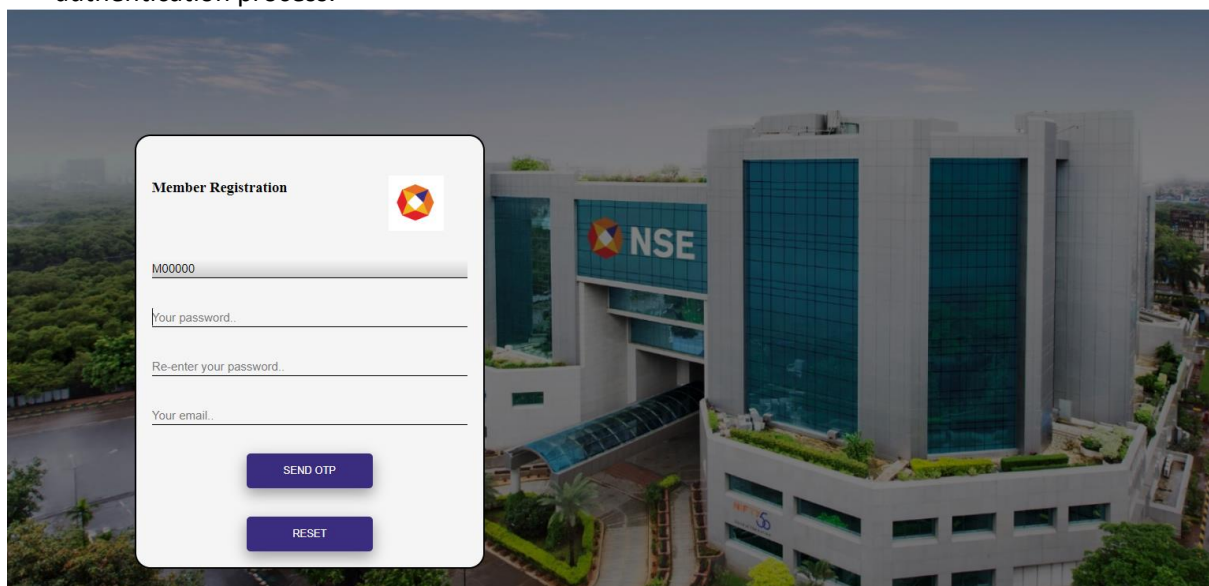

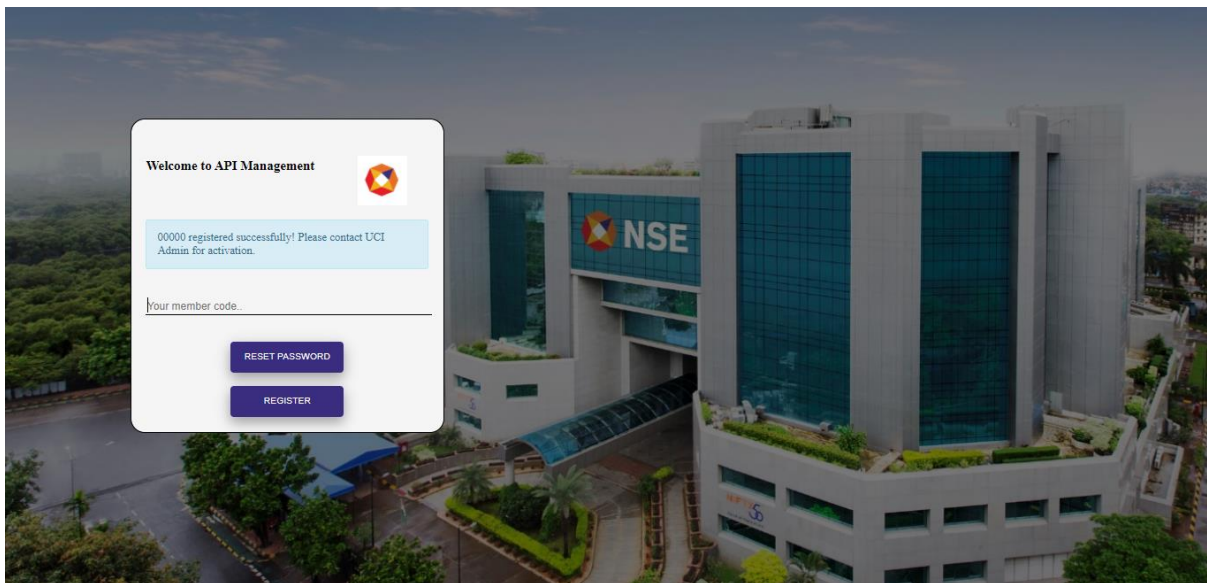
- Use the above one-time user registration link and complete the simple registration process by providing valid 'membercode', 'password' and 'emailid' in below and its subsequent page.



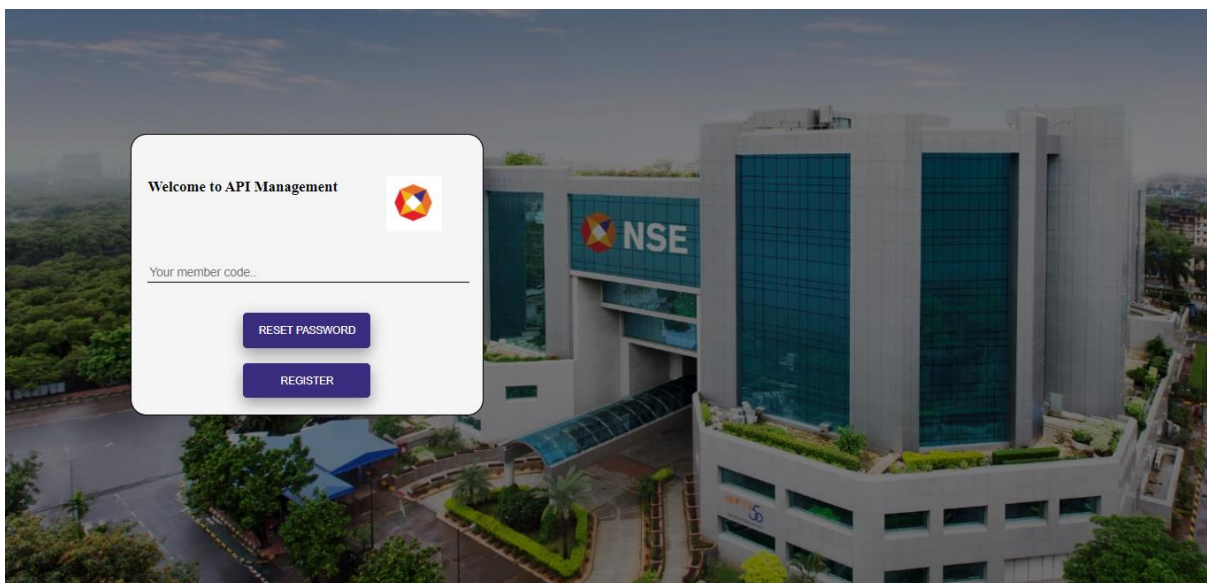
- User/Member will receive an OTP on the given email id by clicking the 'SEND OTP' button. Use the OTP to complete the process. This 'member code' and 'password' will be used during API JWT authentication process.



- On successful registration, user will see a message – “XXXXX registered successfully! Please contact UCI Admin for activation.” Member need to intimate Exchange for Activation on Email ID- uci@nse.co.in



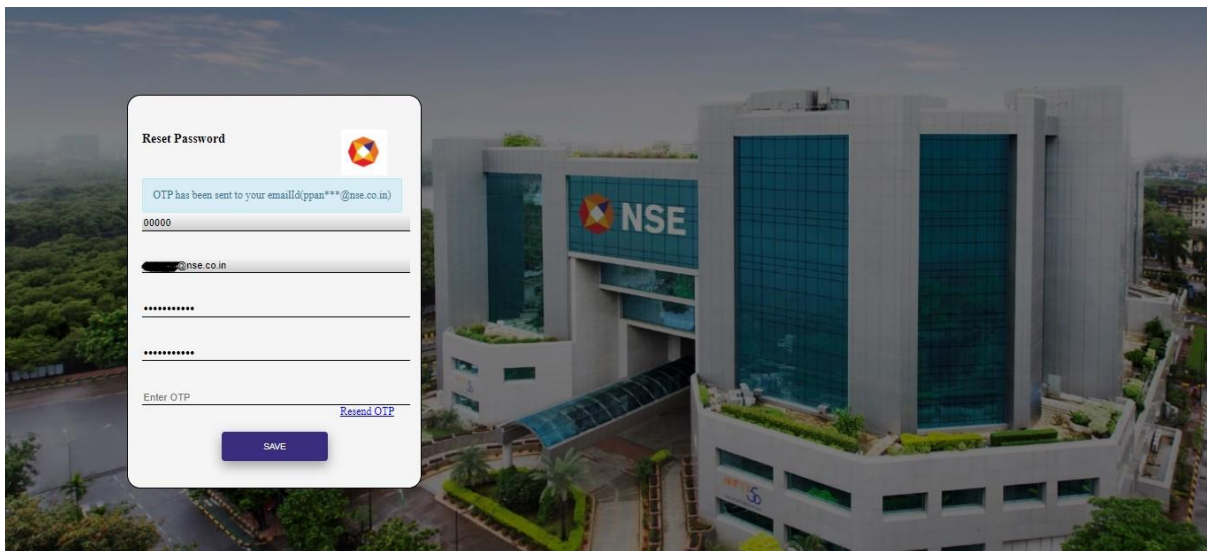
- Follow similar process for resetting the password.
- To reset password, enter the member code and click on RESET PASSWORD button.



- Enter new password, confirm the new password and then click on SEND OTP button to receive the OTP on the registered mail ID as shown in the below image.



- Enter OTP and click on the SAVE button as shown in the below image.



- You will be redirected to the welcome page with the message as shown in the below image.

This API is used to authenticate the user and provide a short life authentication token to use the subsequent API.

2. Upload/ Process Client API

- API Description

This API is used to create a client information in the UCI system. It validates the client information provided before persisting to the system. The validation includes basic field level value against its data type and standard UCC business logic validations. If the validation fails, then the respective validation message is returned to the end user.
