3. Subscription units pay-in and pay-out for orders placed on March 28, 2025 and April 1, 2025 shall be on April 2, 2025
4. Redemption units pay-in and pay-out for orders placed on April 1, 2025 shall be on same day
5. There shall be no redemption funds pay-out on April 1, 2025
