Extranet API facility - Update

This is in continuation to Exchange circular NSE/MSD/55542 dated February 08, 2023 regarding Enhancement in Extranet Functionality.

A) API version 2.0

- As informed in the aforesaid circular, Exchange has introduced new feature in Extranet API where the admin user of the member can now provide controlled access to its sub users for specific segments / services (Segments -CM, CD, FO, DEBT, CO, SLB and Services- Extranet-Common)
- For testing this feature in UAT, API version 2.0 is provided as attached in Annexure 1. Members may also note that to test the existing LIVE API features and functionalities, either API version 2.0 or version 1.0 can be used
- Extranet API version 2.0 shall be released in LIVE w.e.f March 20, 2023.
