ENIT – User Trading Rights Module

The trading system of the Exchange is accessed by a trading member through various modes of connectivity with unique combination of TM/ User ID/ Box ID/ IP and Password. Exchange, at the time of member onboarding allocates such unique user IDs with specific segment wise access and subsequently basis request received through ENIT.

Currently, any User ID allotted by Exchange is assigned “Only CLI” trading rights, which is later modified by trading member based on their usage i.e., CLI to PRO or PRO+ CLI. Such modification requests of trading rights requests are raised by members on ENIT which is being processed by Exchange on timely basis.

In view of Exchange circular no. [NSE/COMP/58554](#) dated September 25, 2023 regarding requirement of Base Minimum Capital (BMC) and in partial modification to Exchange circular reference [NSE/MSD/47244](#) dated February 04, 2021, members are requested to note that w.e.f October 09,2023, User id allotted by the Exchange based on member request shall be created without any trading rights. Members desirous to trade through such newly allotted user id shall request for trading rights through ENIT in line with BMC category as per below process:

1. The Current Name for “PRO Trading” module is now renamed to “**User Trading Rights**” module.

- Members may please be advised that the existing trading rights (PRO/CLI/PRO+CLI) shall remain unchanged on account of release of this module . However, members are requested to align user trading rights for their existing and new user ids allotted based on their BMC category by referring to “Trading Rights Status Report” available in User Trading Rights module on ENIT.
- Additionally, user trading rights (PRO / CLI/ PRO+CLI) shall be removed in case of shifting of user IDs requests raised through the below module of ENIT:

Members are requested to avail appropriate trading rights by placing user trading rights request for such user ids which are requested for shifting.

- Members are requested to carefully read the attached user manual for desktop and mobile application before submitting the request on ENIT. The same is available on the ENIT module as well.
- For orderly roll out of this facility, the ENIT PRO module will be unavailable to members from 3.30 p.m. on Friday, October 06, 2023, till Saturday , October 07, 2023. Members may plan their activities accordingly.
