Introduction of Weekly frequency under Systematic Investment Plan (SIP) facility

Notice is hereby given to all the investors / unit holders that Weekly frequency under Systematic Investment Plan ('SIP') facility will be introduced in the select schemes of Invesco Mutual Fund (**the Fund**) w.e.f. **September 15, 2025**.

The key features of Weekly frequency SIP facility are as follows:

- a) Eligible schemes of the Fund & Minimum Amount:

- b) Investors can invest a fixed amount through Weekly frequency SIP under Growth option only.
- c) Minimum number of installments for availing Weekly frequency SIP is 12.
- d) SIP day can be any day between Monday to Friday of the week. In case the day is not specified or in case of ambiguity, Monday will be considered as default day of for the SIP installment.
- e) Instalment under Weekly frequency SIP will be processed on Business Days only. If the instalment under Weekly frequency SIP falls on a non-business day, it will be carried forward to the next business day.
- f) Investors will have the right to discontinue the Weekly frequency SIP at any time by submitting request for cancellation. On receipt of such a request, Weekly frequency SIP facility will be cancelled within 2 business days from the submission of such request by the investor.
- g) The Weekly SIP registration will be discontinued in cases where three (3) consecutive installments are not honored.
- h) Investors availing Weekly frequency SIP can avail Top-up facility. SIP Top-up frequency will be half yearly / yearly. The minimum Top-up amount will be Rs. 100/- and in multiples of Re. 1/- thereafter.
- i) Pause SIP and Modify SIP facility will be available under Weekly frequency SIP. Modification options will be available only to investors whose SIPs are registered through NACH mandate.

Invesco Asset Management (India) Pvt. Ltd. (**'IAMI'**) reserves the right to change / modify the features of Weekly frequency SIP in future.

All other features, terms & conditions of SIP applicable under existing frequencies will also be applicable to Weekly frequency SIP.

Pursuant to introduction of weekly frequency SIP facility, necessary changes will be carried out at relevant places in Statement of Additional Information (**SAI'**) of the Fund and Scheme Information Document(s) (**'SIDs'**) & Key Information Memorandum(s) (**KIMs'**) of the above mentioned schemes of the Fund.

All other terms & conditions of the SAI of the Fund, SIDs and KIMs of the above-mentioned Schemes will remain unchanged.

This addendum forms an integral part of the SAI of the Fund, SIDs / KIMs of the above-mentioned Schemes as amended from time to time.
