1.	STP Frequency & Default Day	<ul style="list-style-type: none"> Weekly STPs can be initiated on any day from Monday to Friday, as per investor’s choice. If no day is selected, the default day will be Friday. If the STP date falls on a holiday, the transaction will be processed on the next working day.
2.	Eligibility Criteria	<ul style="list-style-type: none"> No minimum balance is required in the Transferee scheme for registration of an STP/ SWP.
3.	Processing Timeline	<ul style="list-style-type: none"> The minimum number of days required for registration and cancellation of STP/SWP will be 7 calendar days from the date of receipt of the registration/cancellation request.
4.	SWP Default Date	<ul style="list-style-type: none"> In case no date is selected by the investor, the default SWP date will be the 15th of every month. If 15th is a holiday, the SWP will be processed on the next business day.
