**NOTICE CUM ADDENDUM TO THE SCHEME INFORMATION DOCUMENTS ('SIDS') AND KEY INFORMATION MEMORANDUMS ('KIMS') OF CERTAIN SCHEMES OF PGIM INDIA MUTUAL FUND**

**Revision of subscription limits for designated schemes of PGIM India Mutual Fund**

We refer to our Notice Cum Addendum dated March 09, 2026 regarding temporary suspension of subscriptions in PGIM India Global Equity Opportunities Fund of Fund, PGIM India Emerging Markets Equity Fund of Fund and PGIM India Global Select Real Estate Securities Fund of Fund ('**Designated Schemes**') read with our Notice Cum Addendum dated May 15, 2026 regarding reopening of subscriptions in Designated Schemes.

SEBI vide its letter no. SEBI/HO/OW/IMD-II/DoF3/P/25095/2022 dated June 17, 2022 has permitted Mutual Funds to accept subscriptions and to invest in overseas funds /securities upto the headroom available without breaching the overseas investment limits as of EOD of February 1, 2022 at Mutual Fund level.

In view of the same, the AMC has decided to revise the subscription limits in the Designated Schemes with effect from June 05, 2026, in the following manner:

Sr. No.	Transaction Type	Impact
1.	Fresh Systematic Registration (Systematic Investment Plan)	Maximum of INR 50,000/- per day, per investor, per scheme (at Primary holder PAN level) received before the cut-off time on any business day.
2.	Fresh Systematic Transfer Plan (Transfer Plan into any of the Designated Schemes)	Shall not be accepted post the cut off timing of June 04, 2026.
3.	Installments of Systematic Investment / Transfer Plans existing as on June 04, 2026.	Existing Systematic Investment Plan / Systematic Transfer Plan instalments will continue.

This Notice-cum-Addendum forms an integral part of SIDs and KIMs of the Designated Schemes, as amended from time to time. All the other terms and conditions of SIDs and KIMs of the Designated Schemes will remain unchanged.
