Sub: Graded Surveillance Measure (GSM) - Periodic relaxation of Surveillance action

This has reference to Exchange circular(s) NSE/SURV/34262 dated February 23, 2017, introducing Graded Surveillance Measure framework and NSE/SURV/42135, NSE/SURV/42790, NSE/SURV/54772 dated September 13, 2019, November 29, 2019, and December 09, 2022, respectively, regarding update on Graded Surveillance Measure.

As per the provisions of GSM framework, a periodic review of securities under GSM, to assess relaxation of surveillance actions has been carried out in coordination with the other Exchanges. The securities eligible to move to lower stages of GSM framework w.e.f. January 09, 2023; are given in Annexure.
