The Committee was informed that the Board of Directors (the 'Board') vide its resolution passed on November 3, 2022 had enhanced the powers granted to the Committee to avail the fund based borrowing facilities from Rs 1,000 crores to Rs 1,500 crores in partial modification to the resolution passed by the Board on May 6, 2021.

The Committee was further apprised that for administrative convenience it would be necessary to modify the list of authorised signatories for raising funds for working capital requirement through Commercial Papers.

After due deliberations, the Committee passed the following resolution:

"RESOLVED THAT pursuant to the powers conferred by the Board vide resolution dated November 3, 2022, in this regard, Mr Vir S Advani, Vice Chairman & Managing Director, Mr B Thiagarajan, Managing Director, Mr Nikhil Sohoni, Group Chief Financial Officer, Mr Kundip Thakker, Head Treasury & P2P, Mr Snehal Suchak, Senior Manager - Treasury, Mr Rajesh Parte, Company Secretary & Compliance Officer (the 'Authorised Signatories') be and are hereby severally authorised to borrow funds from banks or financial institutions, by way of commercial papers, at such rate of interest for such period and upon such terms and conditions as may be negotiated and finalised by any one of the Authorised Signatories in the best interest of the Company, subject to the condition that the total amount borrowed and outstanding at any time shall not exceed Rs 1,500 crores (Rupees One Thousand Five Hundred Crores only).

RESOLVED FURTHER THAT any of the aforesaid Authorised Signatories be and are hereby severally authorised to do all such acts, matters and things as may be required by the banks, financial institutions, the depositories and other regulatory authorities to get the Commercial Papers of the Company listed on the Stock Exchanges.

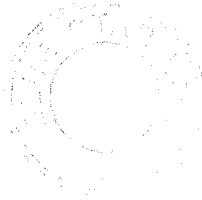
