In view of the above, vide letter dated November 10, 2025, SEBI has acceded to the request of SIDBI to consider all Non – Executive Directors as Independent Directors as provided under Regulation 16(1)(b) of the SEBI LODR 2015, subject to compliance with the laws prescribed for appointment and constitution of a Board in SIDBI Act.
