Sub: Voluntary Strike-off and dissolution of Cheshire Salt Holdings Limited and New Cheshire Salt Works Limited, wholly owned subsidiaries of the Company

Pursuant to Regulations 30 and 51 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), we wish to inform that Cheshire Salt Holdings Limited and New Cheshire Salt Works Limited, wholly owned subsidiaries of the Company had made an application for voluntarily strike-off and the said entities are dissolved from the Companies House, UK effective today i.e. April 14, 2026.

Accordingly, Cheshire Salt Holdings Limited and New Cheshire Salt Works Limited have ceased to be wholly-owned subsidiaries of the Company.

These changes will result in simplification of the group holding structure without any change in the ultimate ownership of the Company over its UK holding and operating subsidiaries.
