Sub: Initial public offering of equity shares of face value of ₹1 each (“Equity Shares”) of Moneyview Limited (“Company” and such offering the “Offer”)

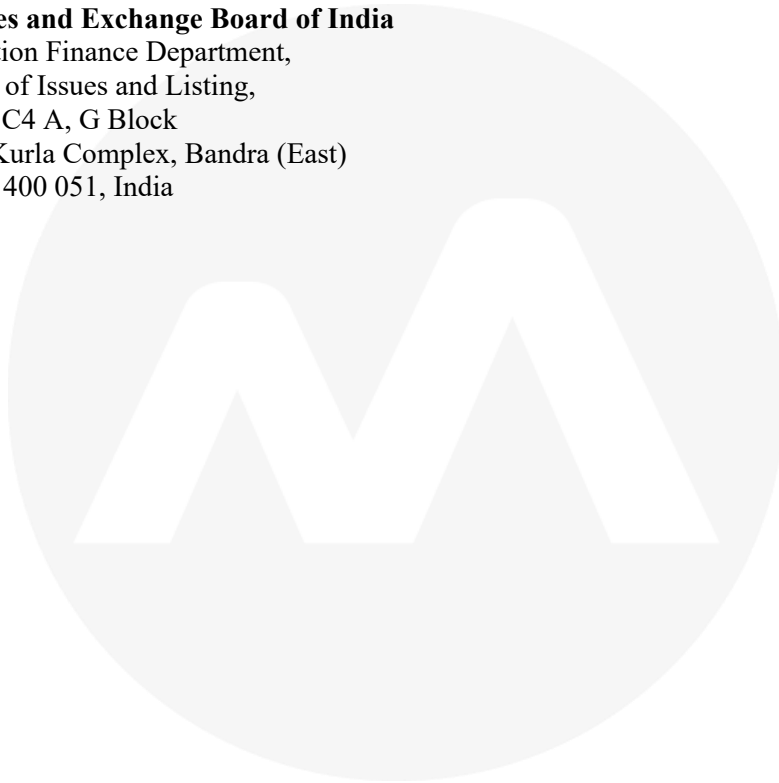
