In terms of the RHP or the Preliminary Offering Memorandum, as applicable, and the SEBI ICDR Regulations, 40% of the Anchor Investor Portion was reserved as under (i) 33.33% for allocation to domestic Mutual Funds and (ii) 6.67% for allocation to Life Insurance Companies and Pension Funds at or above the Anchor Investor Allocation Price.

Out of the total allocation of 93,08,667 Equity Shares to the Anchor Investors, 60,41,249 Equity Shares were allocated to 16 domestic Mutual Funds applying through 30 schemes. Set forth below is the scheme-wise details of the mutual funds:

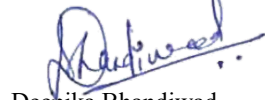
