40% of the Anchor Investor Portion, was reserved as following: (i) 33.33% was reserved for domestic Mutual Funds; and (ii) 6.67% was reserved for life insurance companies registered with the Insurance Regulatory and Development Authority of India under the provisions of the Insurance Act, 1938 and pension funds registered with the Pension Fund Regulatory and Development Authority under the provisions of the Pension Fund Regulatory and Development Authority Act, 2013, subject to valid Bids being received from them at or above the Anchor Investor Allocation Price. Any undersubscription in the reserved category for life insurance companies and pension funds was made available for Allocation to domestic Mutual Funds.

Out of the total allocation of 34,52,829 Equity Shares to the Anchor Investors, 28,70,321 Equity Shares (i.e. 83.13 % of the total allocation to Anchor Investors) were allocated to 11 domestic Mutual Funds, which have applied through a total of 19 schemes.
