40% of the Anchor Investor Portion, was reserved as following: (i) 33.33% for domestic mutual funds and (ii) 6.67% for life insurance companies and pension funds, in accordance with SEBI ICDR Regulations. In the event of undersubscription in the Anchor Investor Portion reserved for life insurance companies and pension funds, the unsubscribed portion shall be available for allocation to domestic Mutual Funds.

Out of the total allocation of 2,61,31,680 Equity Shares to the Anchor Investors, **1,11,06,668** Equity Shares (i.e., **42.50%** of the total allocation to Anchor Investors) were allocated to **7** domestic mutual funds, which applied through a total of **12** schemes and **35,72,492** Equity Shares (i.e., **13.67 %** of the total allocation to Anchor Investors) were allocated to 3 life insurance companies. Set forth below is a scheme wise detail of allocation to such mutual funds, and details of allocation to life insurance companies and pension funds:
