The National Stock Exchange of India Limited has expelled the trading member Disha Capital Services Limited, with effect from April 1, 2002, due to failure of the trading/clearing member in meeting the capital requirements for continued admittance to the trading/clearing membership of the Exchange/Clearing Corporation.

The trading facility of the member was withdrawn since 10th March, 2000 and was suspended since 1st March, 2001.

Consequently, National Securities Clearing Corporation Ltd. has also expelled the said clearing member, Disha Capital Services Limited with effect from April 1, 2002.
