### The list of 73 securities attracting additional security specific margin effective from January 05, 2000

In view of the volatile market scenario the Clearing Corporation has decided that scrips witnessing price volatility of more than 250% in the past 6 weeks and having low liquidity would attract an additional security specific margin of 50%.

The list of scrips attracting this additional margin would be announced to members from time to time (normally at the beginning of a settlement and along with the list of scrips subject to volatility margin).
