Press reports regarding Nath Seeds Limited

The press today had reports regarding Nath Seeds Limited planning to offer 26% stake to a strategic partner through the private placement or preferential offer route.

The Exchange in order to verify the accuracy or otherwise of the information reported in the press and to inform the market place so that the interest of the investors is safeguarded, had written to the officials of the company.

Nath Seeds Limited vide its letter dated January 13,2000 addressed to the Exchange has clarified "The company is in negotiation with financial/strategic investors to preferential offer upto 26%. The resources so raised shall be used aggressively to drive company's research endeavours in the field of genetic engineering. Indian Seed industry is highly fragmented with too many small regional players and therefore offer great opportunity for consolidation. Nath is, therefore exploring the possibility of acquisition."
