Govt to auction Rs. 2,500 cr securities

Chennai, May 28: The Government of Tamil Nadu has announced the sale of government securities worth a total of Rs.2,500 crore through auction. According to the Finance (Ways and Means-II) Department, the State Government will issue 7-year securities worth Rs.1,000 crore, 10-year securities worth Rs.1,000 crore, and 15-year securities worth Rs.500 crore.

The auction will be conducted by the Reserve Bank of India at its Mumbai Office, Fort, Mumbai, on June 2. Competitive bids can be submitted electronically through the Reserve Bank of India's Core Banking Solution (E-Kuber) system between 10:30 a.m. and 11:30 a.m., while non-competitive bids will be accepted between 10:30 a.m. and 11:00 a.m. on the same day.

The announcement was issued by the Additional Chief Secretary to Government, Finance Department.
