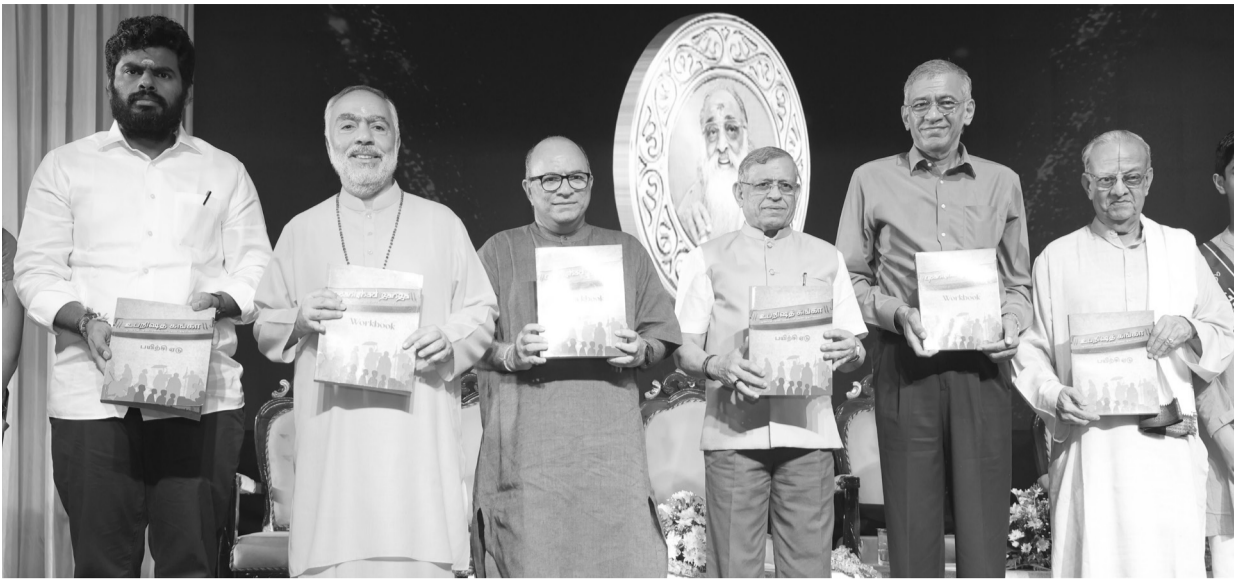

# Paediatrician vaccinates underprivileged girls on Girl Child Day

Chennai, Jan 30: This National Girl Child Day, Dr. D.
