# From khadi to corruption: How India’s politicians traded simplicity for sycophancy – and common man pays price

I used to wake up every morning to the crisp rustle of newspapers — editions fresh off the press, packed with politics, promises, and a fair share of pretense. I would scan for the day’s most intriguing stories and pen my thoughts on them. But today’s news isn’t just interesting — it is an eye-opener. It took me back in time and brought forth a tsunami of comparison between then and now. Specifically, it was about how drastically the cost of living — and the cost of honesty — have skyrocketed. Let’s rewind a bit. **Yesteryears: When Life Was Simpler, Values Were Richer** I vividly recall post-independence India — a country bruised by colonial rule but still brimming with idealism. Even the politicians, believe it or not, were once human beings. They wore khadi dhotis and simple shirts, travelled in Ambassadors, and spoke in humility, not hubris. I remember seeing candidates for Parliament arrive with maybe one or two aides — not a convoy of bulletproof SUVs flanked by muscle-bound sycophants and gun-toting henchmen. As a boy, I worked for the Congress office during elections. We used to write voter slips for Re. 1 a day. That rupee came with tea and biscuits and, occasionally, a sense of purpose. The election fever then was about democracy. Now, it’s a festival of deceit, fueled by freebies, caste equations, and currency notes stacked higher than the promises made. Let me give you an example. My father would hand me Rs.15 to buy vegetables. I would go to our regular vendor, and he would fill two baskets with the

freshest Ooty produce: carrots, cabbages, cauliflowers, potatoes, onions, beans, drumsticks —always with a smile and a handful of coriander and chillies thrown in for free. He even helped carry the baskets to our Austin car. That was India then — polite, personal, and profoundly human. Even the humble Udupi hotel — a bastion of vegetarian delights — served crisp masala dosas with sambar and vadai for 1.5 annas. Yes, annas! Try ordering that now and you’ll be lucky if you can afford the GST on the dosa. Today’s India: A Nation of Empty Wallets and Full Stomachs — At the Top Fast-forward to 2025. The same dosa now costs Rs. 180 in a steel-and-glass cafeteria run by a corporate chain owned by a politician’s nephew. The vegetable vendor has been replaced by an app — one that inflates prices during rain, elections, and bad moods. **What about our politicians?** Gone are the dhotis. In are designer jackets, luxury watches, and foreign holidays disguised as “official visits.” Some of our MPs have declared assets that would make even Ambani blush. From selfless servants of the people, they’ve become high priests of excess — funding lifestyles on a diet of public money and corruption. Corruption, by the way, is no longer a stigma. It’s an asset class. A portfolio item; A career path. **Let’s Talk Numbers: How the Tax Burden Shifted from Ministers to the Masses** In 1945, the tax-free limit was Rs. 1,500. A person earning Rs. 5,000 paid just one anna in tax. At a time when the barter system still thrived in rural areas,
