1. NAME

The Association hereby formed shall be known as "SWAYAM SHIKSHAN PRAYOG" ^{MUMBAI} which, for brevity's sake, hereafter is referred to as "SSP".

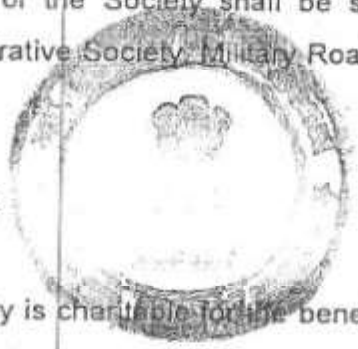
2. OFFICE

The Registered office of the Society shall be situated at ^{Premji Gopalan e/o Shri K. Gopalan} Flat 16, Building 6, Blossom Housing Cooperative Society, Military Road, Marol, Andheri East, Mumbai 400059

3. AIMS AND OBJECTS

The objects of the Society is charitable for the benefit of all persons irrespective of caste, creed, community, language and gender. In pursuance of above object but not limiting thereto:

- a) To promote the social, economic and cultural development of the underprivileged in urban and rural India.
- b) To promote the capability of the underprivileged to utilize community and outside resources to fulfill their needs and promote development.
- c) To promote the acquisition and spread of knowledge and skills among individuals, groups, organizations and communities.
- d) To promote the intellectual, ^{needy & poor} social and economic development of the underprivileged and especially of women.
- e) To promote the status of women and enable them to achieve their rightful place in society.

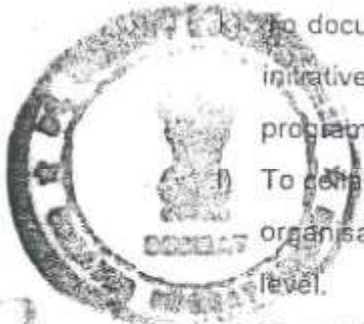

 - g) To promote programs of genuine education among the underprivileged.
 - h) To experiment, evolve, develop and disseminate communication media and methods which promote the objectives of the organisation.
 - i) To undertake research which is meaningful to the organization and the underprivileged.
 - j) To facilitate community based organizations, women's savings and credit groups, community based organisations and local self governments to build capacities in relation to savings and credit, livelihoods, management and maintenance of community based resources such as drinking water, natural resources, monitoring basic services - health, education, child care and anti-poverty schemes, construction work and village development process.
 - k) To document and publish field case studies, research studies, training reports, initiatives of NGOs and government in the implementation of development programs.
 - l) To collaborate with and promote a network of other like-minded persons, groups, organisations and communities at the local, state, national and international level.
 - m) To establish branches, sub-centres in any part of the country and to conduct, arrange, organise any program anywhere within the country for achieving the objectives of the Society.
 - n) To develop, distribute and circulate audio-visual learning materials and software and to create facilities for the acquisition, storage, production and dissemination of the same.
 - o) To organize seminars, workshops, conferences, exchange visits, study tours, and learning exchanges in different sectors of development.
 - p) To do all such lawful acts and deeds as are essential or conducive to the attainment of the objects of the Society.

RULES AND REGULATIONS

OF

THE SWAYAM SHIKSHAN PRAYOG, MAHARASHTRA

सहायक संस्था निदेशक
स्वायं शिक्षण विभाग, मुंबई

1. Interpretation: In these rules, the following expressions shall unless repugnant to the context have the meaning herein assigned to them
 - i. The Association means the "Swayam Shikshan Prayog for brevity called SSP.
 - ii. 'General Body' means the General Body of the Association.
 - iii. 'Governing Body' means the Body which under these regulations is constituted to be the Governing Body of the Association to whom the management of the affairs of the Association is entrusted as required by the General Body
 - iv. 'Seal' means the common seal of the Association.
 - v. 'Act' means the Societies Registration Act, 1860.
 - vi. 'Year' means the financial year commencing from 1st April and ending 31st March of the next calendar year.
 - vii. The words importing 'masculine' gender and 'singular' number shall respectively include 'feminine' gender and 'plural' number and vice versa.

Area of Operation - All India



2. Membership

- The members of the Association shall consist of:
- i. The members who have signed the Memorandum - Founder Members
 - ii. Life Members
 - iii. Patron Members

A person who has attained the age of 18 years and is in agreement with the objects of the Society and whose application is accepted by the Governing Body is eligible to be the member of the Society on payment of the membership mentioned here in below.

3. **Membership Fee**

- i. Life Membership Fee is Rs. 5,000/- payable in one lump sum or in installments payable within the financial year. The membership will be confirmed only on payment of full membership fee.
- ii. Patron members shall pay a sum of Rs. 10,000/-.

4. **Cessation of Membership**

A member shall cease to be a member:

- i. on his resigning from the Association
- ii. on death
- iii. if found guilty of misconduct or conduct subversive to the objects of the Association, by a resolution of the Governing Body which resolution has been passed by 3/4 majority of the Governing Body after calling for the explanation from the member.
- iv. if convicted for any offence involving moral turpitude

5. **Re-admission of Members**

A person who has resigned or was removed from the membership of the Association may seek re-admission, submitting a fresh application. The Governing Body shall have the discretion to readmit or reject the application. The member would have to pay the membership fees once again.

6. **Register of Members**

The Association shall maintain a list of members as per provision of Rule 15 of the Societies Registration (Maharashtra) Rule 1971 in the form of Schedule to the said rules in respect of such members as are members within the meaning of Section 15 of the Societies Registration Act 1860, giving the names, addresses and occupations of the members.

7. **Funds**

The funds of the Association shall be acquired by means of :

i. **Membership fee.**

Life membership fee and Patron fee shall be credited to the Reserve Fund.

ii. **Donation.**

iii. **Grants and loans from state & central governments, local authorities and other national and international bodies/ agencies.**

iv. **Subsidies and grants from local authorities, state and central governments.**

v. **Gifts from any source which does not either compromise the objectives of the association or conflict with regulations set down by the Government in the Act under which this Association is formed.**

vi. **Interests and income derived from investments, rents, subscriptions fees, sales and services rendered.**

8. **Members Rights and Privileges**

All members shall be entitled to attend and participate at the Annual General Meetings of the Society and shall be entitled to receive copies of the reports of the Society.

General Body

The General Body shall consist of :

Founder Members, Life members and Patron members.

Annual General Meeting

Annual General Meeting of the Association shall be held not later than 30th ~~June~~ ^{June} ~~September~~ every year to transact the following business:

- i. to receive the report of the Governing Body and the duly audited accounts of the Association for the year ending on 31st March last preceding the date of the meeting and Auditors report thereon
- ii. to elect such number of persons to the Governing Body
- iii. to appoint an auditor or auditors and fix their remuneration

iv. to transact any other business which may be brought forward by the Governing Body or by any member of the Association of which seven days notice has been given to the Governing Body or with the previous permission of the Chairperson.

11. Extra Ordinary / Special General Meeting

Governing Body may call an Extra-ordinary / Special General meeting of the Society as an when found necessary. (X)

12. Governing Body:

i. The Governing Body shall have the entire control and management of the business and affairs of the Association and administration of all its properties, movable and immovable and shall have all such powers of the Association and do all such things to carry out the objects of the Association as are, by the Act, not required to be exercised or done by the Association in the General Meeting.

ii. The Governing Body shall consist of not less than ^{seven} five and until otherwise determined by the General Meeting not more than nine members.

iii. The Members of the Governing Body shall be liable to retire on the termination of the Annual General Meeting held in every third year. The first Governing Body, however, will continue until the first General Body meeting is called after the first year of its existence.

iv. The Governing Body may fill up any vacancy occurring in the Governing Body by coopting any member of the Association. Such Coopted members shall continue to be the member of the Governing Body until the conclusion of the next General Body Meeting.

v. The Governing Body is empowered to vary the number within the limits mentioned in Rule 12 (ii) herein above

vi. Governing Body Member ceases to be a member if:
a) his/her term of office of three (3) years is over
b) he/she resigns

- c) he/she is requested to resign by 3/4th of the fellow members of the Governing Body
- d) he/she becomes of unsound mind
- e) he/she is convicted of an offense involving moral turpitude

13. Office Bearers

The Governing Body Members to elect among themselves following office bearers:

- i. Chairman
- ii. Secretary
- iii. Treasurer

14. Governing Body Meeting

Governing Body shall meet as many times as it is found necessary *once in four months*

15. Notice

Notices of all meeting of the Governing Body including the adjourned meetings shall be given to members in writing at least five days before. The notice for any General Body Meetings of the Association shall be given at least fourteen days before the date fixed for the meeting.

In case of emergency, short notices may be sufficient if majority of the members agree to the same.



Quorum

3/5th
Fifty percent of the total number of members or three whichever is higher shall be the quorum for the Governing Body. *3/5th*

Quorum for the General Body shall be ~~fifty~~ percent of the membership or twenty whichever is lower.

17. Resolution

- i. Any decision passed by the majority of members shall prevail and be binding on the minority as well as those who may not have voted.

- ii. If the members of the Governing Body are equally divided the matter shall be decided according to the casting vote of the Chairperson of the Meeting.
 - iii. Any resolution shall be deemed to have been duly passed by the Governing Body by circulation if the resolution has been circulated in draft together with the necessary papers, if any, to the members for the time being and has been approved by the majority of the members of the Governing Body.

18. Voting

At every meeting of the Association or the Governing Body every member present shall have one vote. In the case of a tie the Chairperson of the meeting shall have a second casting vote.

19. Powers and Duties of the Office Bearers

Chairperson

The Chairperson shall preside over all the General Body and Governing Body Meetings and shall conduct the proceedings of the meetings in an orderly manner.

In the absence of the Chairperson members present at the meeting shall elect one among themselves to be the Chairperson of the meeting.

Secretary

The Secretary shall be the Executive Director of the Association. He/she shall

- i. Represent the Association in public in every way that benefits Association and in propagating the ideas of the Association.
- ii. Convene the meetings of the Governing Body and General Body
- iii. Be the Ex-officio Secretary member of any Committee or Sub-committee that may have been formed here in after for any purpose.

- iv. Maintain the register of members
- v. Maintain the minutes of the proceedings of all the meetings
- vi. Use or defend in the name of the Association and have executive powers of attorney wherever so required
- vii. Do all such acts and things as to carry out the objectives of the Association.

Treasurer

He/she shall keep proper accounts of the Association and maintain such Account books as is found necessary. It shall be the duty of the Treasurer to get the accounts audited and present the same to the Governing Body.

20. Powers and Duties of the Governing Body

- i. All the properties, movable, immovable or of any other kind shall stand vested in the Governing Body.
- ii. The management and control of the day to day administration and control of the finances of the society shall be vested in the Governing Body appointed in the manner prescribed in these rules. The Governing Body shall have all the powers necessary for carrying out the objectives of the Society.



In furtherance to, and without prejudice to the general powers conferred by or implied by the preceding sub-clause (b) and all other powers conferred by these rules and subject and above, the Governing Body shall have the following powers and will perform the following functions:

- a) To appoint any sub-committees and to delegate, subject to such conditions as they think fit, any of their powers to these sub-committees.
- b) To invite persons and institutions, corporations/ organizations and other like bodies to become members and the association and to decide their fees;
- c) To open, operate and maintain a bank account or accounts in the name of the Association at such bank or banks as they may from time to time decide, or cause to be paid or withdraw any money, to credit any such

accounts either by way of fixed deposits or current accounts or any other accounts.

- d) To invest at their discretion all moneys in their hands which may require investment in or upon any one or more of the securities or deposits or other investments as allowed by any law in force and have power from time to time at its discretion to convert or vary any investment and Securities held by the Association.
- e) To engage and at its discretion professionals, specialists consultants experts, officers, clerks and other cadres of workers and to pay them remuneration, honorarium and benefits as decided by the society and to determine their powers, functions and duties.
- f) To collaborate with other agencies/institutions and network with professionals to further the objects of the Association.
- g) To affiliate itself to any other organization or network either at state, national levels which would be working for the similar aims and objects.
- h) To grant affiliation to such organization(s) in any part of India and which have aims and objects, any or all similar to its own.
- i) To provide, establish, maintain, control and manage educational institutions, libraries, offices, training centers, computers, vehicles, audio-visual equipment, subsidiaries, branches or sub-center in India and do all such things as may be necessary to achieve to the said objectives.
- j) To purchase, lease, hire, rent exchange or acquire by or otherwise movable or immovable property anywhere in India with the rights appertaining there to and to sell, lease, mortgage, develop, invest, withdraw, reinvest and otherwise deal with any moneys, securities and all kinds of movable or immovable property for all or any of the above objectives for which the Society is established.
- k) To accept funds in the form of loans, grants or donations in cash or kind including property, contributions or subscriptions and endowments from the government, industrial and business houses in India and or international agencies and to utilize these funds for the furtherance of the objectives of the Society.

l) To raise or borrow funds for the Association from time to time by gifts, donation etc. from time to time at their discretion and to secure the repayment of such moneys, in such manner and such terms and conditioned in all respects as they think fit.

m) To enter into agreements or contracts for and on behalf of the Association which may be conducive or incidental to the attainment of its objectives.

n) To institute, conduct, defend, submit compromise or abandon any legal proceedings by or against the Association, its office bearers and staff in the business affairs of the Association

o) To solicit and grant scholarships, loans, fellowships, prizes, grants, donations, contributions, subsidies or any other kind of other assistance, monetary or otherwise to individuals, organizations or institutes in the area of development, training and education in the country.

p) To make, execute all such documents and instruments as may be necessary for carrying on the management of the property or the affairs of the Association.

q) To control, administer, dispose of the property and funds for the Association and to invest the funds of the Association in whatever manner it deems fit.

To establish, support and give aid in the establishment and support of associations, institutions, revolving funds and trusts established for the benefit of the community and whose objectives are in conferment with the objectives of the society.

To construct upon any premises acquired for the purpose of the Association, any building or buildings in furtherance to the objectives of the association and to alter, add to or improve any building upon such premises, or to take any building on rent for the running of programmes and other affairs of the Association.

t) To appoint any sectional Committee or Sub-Committee consisting of members and/or non-members as and when necessary and assign to them such duties and delegate to them such powers as the Governing Body may deem fit.

The Governing Body members shall be entitled to reimburse themselves out of the Association estate, all expenses incurred in or about to for the execution of the association or powers or in carrying out the activities of the trust, its objects and affairs or the realization preservation or benefit of the Association properties. The Governing Body members shall be entitled to be indemnified by the Association properties against the consequences of all lawful acts performed by the Governing Body members in their course of and in discharge of their lawful duties.

20A. *Loans and Deposits, Sale and purchase of immovable property procedure laid down in Section 35 and 36 of the B.P.A. Act 1950 will be followed.*

21. Personal Liability

No member of the Governing Body or any of its office-bearer shall be personally liable for anything done by him/her bona fide and during the discharge of his/her duties nor shall he/she be responsible for any fraud, misappropriation, misconduct or neglect of duty of any of the other members or of any members of the staff of the Association.

22. Amendment

Any repeal, variation alteration or addition to the Memorandum of Association, Rules and Regulations of the Association shall be made at the Special General Body Meeting provided that at least 3/5th of the total members present and voting in the said meeting so called shall vote in favour of the proposed change, repeal, variation, alteration or addition. *Procedure laid down in Section 12 and 12A of S.R Act 1860 will be followed.* PROVIDED that in the case of any alterations abridgment or addition to the objects of the Association or its amalgamation with another Society the provisions of Section 12 of the Act shall apply.

23. Dissolution

i. Any number not less than three fifth of the members of the Association may determine that it shall be dissolved and there upon the Associates shall be dissolved forth with or at such time then agreed upon.

If upon the dissolution there shall remain after the satisfaction of all debts and liabilities any property whatsoever the same shall not be paid or distributed among the members but shall be transferred to some other Association to be determined by 3/5th and of the members present personally or by post at the time of the dissolution or in default there of as may be determined by the Court. *Procedure laid down in Section 13 and 14 of S R Act 1860 will be followed.*
