Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations')- Temporary disruption of operations of M/s Aero Care Personal Products LLP due to flooding

Pursuant to the provisions of Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, We wish to inform you that the operations at the **M/s Aero Care Personal Products LLP's ('Aero Care')** (Subsidiary of Hindustan Foods Limited) manufacturing facilities situated at Survey No. 284/2, Village Naroli, Silvassa - 396 235, Dadra and Nagar Haveli and Daman and Diu, have been disrupted due to flooding of the factory premises caused by incessant rainfall and severe waterlogging in the region.

As a precautionary measure and considering the prevailing conditions, operations at the aforesaid manufacturing facilities have been temporarily suspended with immediate effect.

The extent of the damage to the plant and machinery, inventory and other assets is presently being assessed. As access to certain areas of the said manufacturing facilities remains restricted due to waterlogging, the financial impact, if any, cannot be ascertained at this stage.

Aero Care has undertaken all necessary measures to safeguard its assets, assess the extent of damage, and expedite the restoration of operations. The assets at the designated manufacturing facilities are comprehensively covered under insurance.

3.	Estimated impact on the production/ operations in case of disruptions / strike/ lock outs	The estimated impact is yet to be quantified and Aero Care is assessing the same. We expect that the operations will gradually normalize over the next few days barring any unforeseen circumstances.

Factory/ Unit where the disruption/strike /lock outs take place including reasons for such disruptions	The manufacturing facilities situated at Survey No. 284/2, Village Naroli, Silvassa - 396 235, Dadra and Nagar Haveli and Daman and Diu Temporarily disruption is due to flooding and water logging caused by unprecedented heavy rains and flood like situation in UT of D. D. & D.N.H. and South Gujarat.
