Gujarat man who killed wife, posed as friend to evade cops, gets 7 years in jail

EXPRESS NEWS SERVICE BHOPAL, SEPTEMBER 10

A GUJARAT-BASED Kerala man has been awarded seven-year rigorous imprisonment for allegedly impersonating his friend and landing jobs at several prominent companies, all the while being on the run after allegedly murdering his wife on Valentine's Day in 2003.

Additional Sessions Judge (Bhopal) Swayam Prakash Dubey convicted Tarun Jinaraj under Sections 419 (punishment for cheating by personation), 467 (forgery of valuable security...), 468 (forgery for purpose of cheating), and 471 (using as genuine a forged document) of the Indian Penal Code and fined him Rs 11,000.

"The prosecution has successfully proven beyond reasonable doubt that the accused... forged valuable documents such as a passport, PAN card, driving licence, Aadhaar card, etc., in the name of Praveen Bhatel to establish himself as Praveen," the court said.

Jinaraj was arrested by the Gujarat Police from Delhi on October 5, 2023 after he jumped interim bail in the murder case, the trial in which is still going on in Gujarat. He was first arrested in November 2018, after being on the run for 15 years, and sent to Sabarmati Central Jail where he spent five years as an under-trial.

The impersonation case was filed in Bhopal based on a com-

plaint by Praveen Bhatel, Jinaraj's college friend who ran a judo institute for underprivileged children in Bhopal.

According to the prosecution, after allegedly murdering his wife, Jinaraj went to Bhopal in March 2003 and approached Bhatel for work. Bhatel offered Jinaraj work as a spoken English teacher at his institute. During this period, the prosecution said, Jinaraj allegedly scanned Bhatel's documents, including marks sheets and identity cards, which he used to forge ID cards and education certificates. Jinaraj also obtained a passport for travel to the US while working for a tech company in Bengaluru, the police alleged.

Additional Public Prosecutor Vinod Dubey argued that Jinaraj used the forged documents to deceive several firms, "leading these companies to hire him as their employee/ officer at a higher salary due to his deception". In 2008, Jinaraj married another woman from Pune in 2008 and the couple moved to Bengaluru.

Bhatel found out about Jinaraj's criminal past from a newspaper and filed an FIR at Bhopal's T T Nagar police station.

SURAT COMMUNAL CLASHES

Police seek 14-day remand of accused, court grants two days

TWO DAYS after communal clashes gripped Surat following an alleged incident of stone-pelting at a Ganesh pandal on Sunday night, a local court granted police two-days' remand of 27 persons arrested in the case, here on Tuesday.

The accused were produced before Fourth Additional Civil Judge, Judicial Magistrate First Class, Justice K A Marwaha. The police had submitted an application demanding a remand of 14 days, based on 17 grounds.

Surat police had arrested the 27 accused allegedly involved in pelting the police with stones and assaulting the public at Saiyedpura police chowki on the night of September 8.

The arrested persons were booked under different sections of the Bharatiya Nyaya Sanhita (BNS) pertaining to attempt to murder, voluntarily causing hurt, unlawful assembly, rioting, causing mischief, endangering life, and causing grievous hurt to deter public servant from his duty following a complaint by a sub-inspector of a local police station.

Seeking a 14-day remand, the police argued that the identification parade of the arrested persons was pending and that they needed time for detailed interrogation of many since they were from outside Surat.

It further argued that the immediate gathering of over 200 to 300 accused near Saiyedpura police chowki reflected conspiracy, adding that they needed to

find out about others who could be involved in it.

Besides, they said they wanted to find out from where the accused had brought stones which they threw at police and a few members of the public. The police further said it wanted to know if the alleged miscreants were planning another conspiracy ahead of the upcoming Ganesh Visarjan. Besides, they wanted to find out the "main conspirators behind the entire episode", they said.

District Government Pleader Nayan Sukhadwala was present from the prosecution side while the defence side was represented by over five lawyers including Advocate Zafar Belawala, Javed Multani, Wajid Shaikh, Hasmukh Lalwala, and Zeba Pathan.

Talking to *The Indian Express*, Belawala, one of the lawyers for the accused, said, "Police had demanded 14 days' police remand

with 17 grounds. The court has granted police two days till Thursday afternoon. The court has taken into consideration the gravity of the incident and also that other accused in this offence are yet to be arrested..."

Meanwhile, the six minors detained in the case are in an Observation Home for children.

The teenagers allegedly threw stones at a Ganesh Chaturthi Pandal while travelling in an auto, injuring a visitor in the process.

The first FIR in the case alleged that the stone-pelting incident hurt religious sentiments.

The second offence was registered by Govind Rathod, police-sub inspector, Lalgate police station, against over 200 to 300 people, including 27 who were later identified and arrested.

The FIR stated: "The six minors involved... were brought to Saiyedpura police chowki. A mob of around 200 to 300 men and

women turned up... and pelted the complainant and other policemen with stones. Some among the mob also carried wooden sticks and assaulted the cops..."

The third offence was registered by constable Chetan Parmar of Lalgate police station on Monday, stating, "A group of 70 to 80 people, some armed with wooden sticks, attacked two cars and bikes and later set on fire cars parked at Katargam Darwaja."

Rainfall in Maharashtra, Madhya Pradesh raises water level in Ukai Dam

FOLLOWING RAINFALL in its upper catchment areas in Maharashtra and Madhya Pradesh, authorities discharged 1.19 lakh cusecs of water from the Ukai Dam — the second largest reservoir in Gujarat after Sardar Sarovar. With this, the water level in the dam is just five feet below the danger mark of 345 feet.

On Tuesday evening, the inflow water level in the dam was recorded at 1.03 lakh cusecs while outflow was at 1.19 lakh cusecs. The water level in the dam has now reached 339.25 feet.

The dam authorities have opened seven gates up to 6.5 feet high to discharge the water. Of the total amount, 16,986 cusecs was discharged for hydro-power generation. The rule level of the dam as on September 10 was 340 feet.

According to sources in the flood control department of Surat, rainfall in different talukas in South Gujarat, from 8am to 6pm, was measured at 255 mm in Umrpada taluka (Surat district), while Nizar taluka in Tapi district recorded 66 mm. In Navsari,

Khergam logged 60 mm of rainfall as against Chikhli's 45 mm. In Surat, Bardoli, Palsana, and Kamrej recorded 36 mm, 34 mm, and 30 mm of rainfall respectively.

Talking to *The Indian Express*, Ukai Dam Superintending Engineer Hemant Chaudhary said, "The main reason (behind the discharge) is that several areas in the upper catchment of Ukai Dam lying in MP and Maharashtra have received rainfall. Apart from this, the dam receives 40,000 cusecs of water from Hathnur Dam, and 60,000 cusecs from Prakasha Dam. Both these dams are in Maharashtra."

Chaudhary said, "The present water level in Hathnur dam is 211.77 meters while the danger level is 214 meters. On the other hand, the water level in Prakasha Dam is 108.60 meters while the danger level is 111 meters."

He further said, "The water discharged from Hathnur Dam reaches Prakasha Dam and finally, the total discharged water from both the dams reaches the Ukai Dam. Even today, Umrpada taluka in Surat district received around 10 inches of rainfall and the water found its way into the Ukai Dam."

In Chhota Udepur, leopard mauls forest dept staffer to death

Chhota Udepur: An employee of the forest department was mauled to death by a leopard in Chhota Udepur district, officials said on Tuesday.

The victim has been identified as Ganpatbhai Tettabhahi (45), Range Forest Officer (RFO) Vanraj Solanki said that the victim who was deployed as a watchman was attacked by a

leopard and dragged into Baria forest and his body was found on Tuesday.

Tettabhahi, a resident of Ambakhoot village of Pavi Jitpur taluka, was an out-sourced employee of the forest department, added the official.

The animal had bitten the victim on the back, the official said further.

Two PF officers land in ACB net in graft case

Surat: The Anti Corruption Bureau (ACB), Surat wing Monday arrested an Assistant Commissioner (Provident Fund) and an Enforcement Officer in Gujarat's Vapi, in connection with a bribe case of Rs 5 lakh.

According to the officials, the Provident Fund (PF) office in Vapi had issued a notice to a builder who had allegedly failed to pay the PF of his employees.

The builder in turn had requested the officials to reduce the penalty. According to the officials, the Assistant Commissioner (Class 1 officer) Harshadkumar Parmar and (Class 2 officer) Enforcement Officer Suprabhat Tomar had allegedly demanded Rs 5 lakh bribe to get his work done.

The builder, however, contacted the ACB and lodged a complaint against both officers. Based on the complaint, the anti-corruption bureau laid a trap and arrested the accused, said ACB Surat Assistant Director R R Chaudhary.
