Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform the Exchanges that the Company has received direction from the Gujarat Pollution Control Board, ('GPCB') under Section 33(A) of the Water (Prevention and Control of Pollution) Act, 1974, on January 02, 2025, to close the operations at its plant, located at Plot No. 22/C -1, Phase 1, GIDC, Vapi -396195 Tal; Pardi, Dist: Valsad, Gujarat, India. Further, the GPCB has asked to submit a bank guarantee of Rs. 2,50,000/- for compliance assurance at the time of revocation and has also ordered to deposit interim Environment Damage Compensation amount as and when decided by the GPCB.

We wish to assure our stakeholders that we are taking immediate and appropriate measures to address the concerns raised by the regulatory authorities.
