I further confirm that there is no other material reason other than as mentioned above for tendering my resignation from the post of Chief Financial officer (CFO) & KMP of the Company.


I would like to express my sincere gratitude to the Board and the company for the opportunity and assistance provided during my tenure. and I hope to stay connected in the future.
