तृणमूल कांग्रेस सांसद साकेत गोखले ने मंगलवार को पूर्व राजनयिक लक्ष्मी मुद्देश्वर पुरी से जिनेवा स्थित उनके अपार्टमेंट के संदर्भ में की गयी अपनी टिप्पणी के लिए सार्वजनिक रूप से माफी मांगी। गोखले ने 'एक्स' पर पोस्ट किया कि मैं 13 और 23 जून 2021 को राजदूत लक्ष्मी मुद्देश्वर पुरी से एक खिलौना लिए गए कई ट्वीट के लिए बिना शर्त माफी मांगता हूँ, जिनमें राजदूत पुरी द्वारा मुझे से संपत्ति खरीदने के संबंध में गलत और अशुभ आरोप थे, जिसके लिए मुझे ईमानदारी से खेद है। यह माफी मानहानि मामले में दिल्ली उच्च न्यायालय के निर्देशों के बाद मांगी गई है।

भाजपा नेता अमित मालवीय ने तृणमूल सांसद पर कटाक्ष करते हुए कहा कि उन्होंने सुबह-सुबह एक पोस्ट लिखी कि इस उम्मीद में कि बहुत से लोग उन्हें अपने शब्द वापस लेते हुए नहीं देखेंगे। मालवीय ने कहा कि तृणमूल सांसद साकेत गोखले ने पूर्व राजदूत लक्ष्मी पुरी से एक अखबार में और फिर 3:28 बजे 'एक्स' पर माफी मांगी, उन्हें उम्मीद थी कि बहुत से लोग उन्हें अपने शब्द वापस लेते नहीं देखेंगे। लेकिन इससे मामला और बिगड़ गया। उन पर कपटी होने का आरोप लगाया जा रहा है। भाजपा नेता ने कहा कि मुझे यह भी बताया गया है कि उन्होंने अभी तक

50 लाख रुपए का हर्जाना नहीं दिया है। अदालत ने इस बीच उनके वेतन को जब्त करने का आदेश दिया है। मामले को आक्रामक तरीके से आगे बढ़ाया जा रहा है। ऐसा लगता है कि तृणमूल में उनके आकाओं ने उन्हें छोड़ दिया है। गोखले ने पलटवार करते हुए कहा कि भाजपा आईटी सेल को एक दिन के लिए कुछ काम देने की खुशी है।
