The Company has already started and planned large scale recycling Cotton Waste, Waste Cotton Yarn, Pre & Post Consumer fabrics for making Yarns & Fabrics avoiding dyeing process to make different coloured yarns directly from coloured waste, reducing environmental impact. This recycling business has higher margins than regular yarn business. In addition to above, the company has been expanding its product portfolio by utilizing its yarn for in-house fabric and readymade garment production.
