We wish to inform you that our Company has provided remote E-Voting facility to its shareholders for exercising their right to vote on the resolutions during the ensuing Annual General Meeting scheduled to take place on 30th September, 2025 at 11.00 am through Video Conferencing / Other Audio Visual Means, without physical presence of the members at a common venue for which we have entered agreement with NDSL.

1. Date and time of commencement of remote E-Voting: 27th September, 2025 at 9.00 am
2. Date and time of end of remote E-Voting: 29th September, 2025 at 5.00 pm
3. Cut-off date: 22nd September, 2025
4. A member may participate in General Meeting even after exercising his right to vote through remote e-voting but shall not be allowed to vote again in the meeting
5. A person whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date only shall be entitled to avail the facility of remote e-voting as well as voting in the General Meeting.
6. Notice of the Annual General meeting has been displayed on the web site of the company www.mahaalaxmitexpro.com and on website of e-voting platform provided by National Securities Depository Limited
7. A person who has acquired shares and become member of the Company after send/dispatch of notice of AGM and holding shares as of cut off date, may obtain the login ID and password by sending a request at mumbai@in.mpms.mufig.com .However, if the person is already registered with NDSL for remote e-voting then the existing user ID and password can be used for casting vote.
